Sixteen years ago, a selected group of Camps Board members registered to participate in a program sponsored by the Murdock Foundation out of Vancouver, WA. The training included traveling to Vancouver to meet with other camping programs in the Pacific Northwest. The goal of Murdock, was to provide training on how to financially sustain the operation of a camp, secure donors for special projects and hopefully submit and receive a grant from the Murdock Foundation. The Foundation was created upon the premature death of the founder, Jack Murdock, who co-founded Tektronix in Oregon. One of the principle elements of the Foundation is to support faith-based organizations that emphasize youth. Part of the training encouraged the camps represented to hold an annual event to report to your investors on what was accomplished and what was on the horizon. From this training, Share the Dream was birthed and has been an annual event for the past 14 years. The event started as a meal with sponsored tables for guests and held at the Nampa Civic Center. Then the event moved to the Nampa Christian High School and was a catered dinner by the Camp Food Service. It eventually found its way to Valley Shepherd Nazarene Church as a dessert fellowship in late November or early December. However, 2020 brought another dimension to the history - the first ever virtual Share the Dream. Each Share the Dream has had a theme. LOOKING BACK: In our office, the slower pace of COVID has allowed time to sort through files and toss and review records. I found a letter from March 1998 that I had written to members of the Idaho Senate encouraging them to support legislation that would provide the Idaho Department of Parks and Recreation with \$1 million dollars to purchase a portion of the land at Victory Cove from the Idaho Department of Lands. Governor Phil Batt supported the proposal. The funds were necessary to allow the transfer of the property into the assets of Ponderosa State Park. The letter stated that on February 10, 1998, an agreement had been signed to purchase 196 acres in Cascade, Idaho for a new camp location. The famous piece of legislation that is so important to Trinity Pines history was House Bill 791. The bill passed both Houses for the appropriation and was signed by Governor Batt. All of this started the ball rolling for the development of Trinity Pines.
